**AN ORDINANCE OF WEST PIKELAND TOWNSHIP
AMENDING IN ITS ENTIRETY STORMWATER ORDINANCE NO. 2014-01**

**AN ORDINANCE AMENDING IN ITS ENTIRETY THE WEST PIKELAND TOWNSHIP,
CHESTER COUNTY, PENNSYLVANIA ORDINANCE NO. 2014 -01 AS FOLLOWS TO
ENACT A NEW STORMWATER MANAGEMENT ORDINANCE.**

WHEREAS, the Pennsylvania Stormwater Management Act ("Act 167") of 1978 requires that each county prepare and adopt a watershed stormwater management plan for each designated watershed and provides for the regulation of land and water use for flood control and stormwater management; and

WHEREAS, the Chester County Board of Commissioners adopted Resolution 55-22 on August 17, 2022, to amend the County-wide Act 167 Stormwater Management Plan for Chester County, PA to replace the 2013 model ordinance with the 2022 County-wide Act 167 Stormwater Management Model Ordinance, to fulfill the requirements of Act 167, including to set forth design criteria and standards for storm water management systems and facilities that shall be utilized within Chester County and its watersheds; and

WHEREAS, as a result of this County Resolution, West Pikeland Township has revised its previous Stormwater Management Ordinance to protect public health, safety, and property, to protect water quality of the waters of the Commonwealth, and to prevent or mitigate the adverse impacts related to the conveyance of excessive rates and volumes of storm water runoff and associated pollutants by providing for the management of storm water runoff and control of erosion and sedimentation.

NOW THEREFORE BE IT ENACTED on this 17th day of October, 2022, that the West Pikeland Township Stormwater Management Ordinance 2022-02 (attached) is hereby adopted in the same form and substance as is set forth in the Public Hearing Draft of the Ordinance as outlined below.
