WHEREAS, libraries are accessible and inclusive places that promote a sense of local connection, advancing civic engagement and shared community goals;


WHEREAS, getting a library card opens up endless possibilities for lifelong learning and personal growth;







RESOLUTION NO. 2024 - 12

**A RESOLUTION APPOINTING MEMBERS OF THE HISTORIC
ARCHITECTURE REVIEW BOARD (“HARB”) AND THE HISTORIC
COMMISSION**

WHEREAS, West Pikeland Township, Chester County, Pennsylvania is a Township of the Second Class and;

WHEREAS, the Pennsylvania Historic District Act of 1961 permits the West Pikeland Township Board of Supervisors (the “Board”) to appoint members to the Historic Architecture Review Board (“HARB”) and;

WHEREAS the Second Class Township Code grants the powers to the Township to appoint members to the Historic Commission and;

WHEREAS, the HARB was established by Ordinance No. 14, which outlines the membership, power and duties of the HARB and;

WHEREAS, the members of the HARB are tasked with the responsibility to provide guidance and assistance to the Board, Commissions, Committees and all Officers of the Township in matters relating to Article VII-Act 167 Historic Districts, Section 704, Historic Architectural Review Board of the West Pikeland Township Zoning Ordinance 2005-201 and;

WHEREAS, the Historic Commission was established by Resolution 2005-09-16, which outlines the membership, powers and duties of the Historic Commission and;

WHEREAS, the members of the Historic Commission are tasked with the responsibility to provide guidance and assistance to the Board, Commissions, Committees and all Officers of the Township in matters relating to the integrity and protection of the historic resources of the Township and matters relating to Article VII, Section 804-Historic Protection Overlay District of the West Pikeland Zoning Ordinance 2005-201 and;

WHEREAS, the members of the HARB and Historic Commission may work together in order to properly conduct their duties and responsibilities and;

WHEREAS, the members of the HARB and Historic Commission shall continue to serve as volunteers.

NOW THEREFORE BE IT RESOLVED by the Board of Supervisors of the Township of West Pikeland that:

Section 1. The following individuals, with their respective positions and terms, shall serve on the HARB, until their term has ended:

Peter Moran (Chairman) – *Term through December 31, 2029*

Mark Ashton – *Term through December 31, 2024*

John-Paul McGovern – *Term through December 31, 2024*

John Grablewski – Term through December 31, 2025
Frank Best – Term through December 31, 2026
Tom Williams – Term through December 31, 2028
Rhonda Marks – Term through December 31, 2029
Mike Cosentino of Barry Isett & Associates (Township Zoning & Code Officer)


Section 2. The following individuals, with their respective positions and terms, shall serve on the Historic Commission, until their term has ended:




