



# Proclamation Honoring

## Officer Robert F. McCarron

*Where as* Officer Robert F. McCarron has faithfully served the residents of West Pikeland Township and surrounding communities for over 30 years with dedication, professionalism, and integrity; and

*Where as* Officer McCarron joined the West Pikeland Township Police Department on June 16, 2003, bringing with him extensive experience and a deep commitment to public safety; and

*Where as* during his career, he served in multiple key roles including Motor Carrier Safety Assistance Program (MCSAP) officer, crime scene and evidence technician, field training officer, and instructor in defensive tactics, use of force, and crisis intervention; and

*Where as* he has been recognized for his exceptional service with numerous awards, including DUI Enforcement Awards from Mothers Against Drunk Driving (2001, 2003), a 2005 Congressional Citation for DUI enforcement, a 2004 Heroism Award for rescuing a resident from a fire, and a 2019 Lifesaving Award for emergency medical response; and

*Where as* Officer McCarron has been commended by neighboring police departments for his critical support in serious incidents such as robberies, missing persons, drug investigations, fatal crashes, and warrant operations; and

*Where as* he has been a strong advocate for officer wellness and labor relations, serving as President of the West Pikeland Township Police Officers Association and the Chester County Fraternal Order of Police, and founding the "My Brother's Keeper" mental health initiative; and

*Where as* he has also served the Commonwealth of Pennsylvania with distinction, appointed twice by Governor Tom Wolf to the Pennsylvania Municipal Retirement System Board, currently serving as Chair of the Governance and Personnel Committee and Vice Chair of the Investment Committee; and

*Where as* Officer McCarron will officially retire on August 31, 2025, concluding a remarkable career marked by courage, leadership, and dedication to public service;
