NEW BUSINESS

Chester County Consortium Renewal Engagement Letter. Mr. Romano explained that the Township's cable franchise agreement with Comcast is set to expire in November 2026. This renewal presents an opportunity for West Pikeland Township to secure important benefits and asserts the Township's legal rights with the cable provider. This proposed action was coordinated with Mr. Donatelli, the Township Solicitor, who recommended the BoS to proceed. - Ms. Mifsud made a motion to approve the engagement of the Cohen Legal Group to represent West Pikeland Township in negations with COMCAST. Seconded by Mr. Hallman. The motion was unanimously approved.
